ASSOCIATIONS INCORPORATION ACT 2015

ORDER TO CANCEL INCORPORATION

[Part 10, Division 3, s.147]

On 18 September 2023 the Commissioner for Consumer Protection (Commissioner) served a notice on The Retired Teachers' Association of WA—A0820493V (the Association) pursuant to section 145(1) of the *Associations Incorporation Act 2015* (Act) informing it that if it did not show cause on or before 60 days after the day on which the notice was given (Allowed Period) the incorporation of the Association would be cancelled.

The Association did not show cause within the Allowed Period.

On 12 December 2023, the Commissioner gave notice in writing to the Association pursuant to section 147(2) of the Act stating that the Commissioner proposed to make an order cancelling the incorporation of the Association after the expiration of 28 days from the day on which the notice was given and advising the Association that it could apply to the State Administrative Tribunal (SAT) for a review of the Commissioner's proposal within his period.

The Association did not apply to SAT for a review within the period specified.

Therefore, pursuant to section 147(1) of the Act, the Commissioner orders that the incorporation of the Association be cancelled with effect on and from the date of this order.

1. Citation

These amendments may be cited as the *Electricity Industry (Metering) Amendment Code 2024*.

2. Commencement

This code comes into operation on the day which it is published in the *Gazette*.

3. Code amended

This code amends the *Electricity Industry (Metering) Code 2012*.

4. Clause 7.6 amended

Clause 7.6 is amended by—

- (a) In clause 7.6(2)(a)(vi), after the words “a consultant”, inserting the following—

“

or contractor

“, and

- (b) after clause 7.6(3), inserting clauses 7.6(4), 7.6(5), 7.6(6) and 7.6(7) as follows—

“

- (4) *AEMO* may request a *metering data agent* to disclose *confidential information to AEMO* where—

- (a) the provision of the *confidential information* is necessary for *AEMO* to exercise its functions under the *market rules*; and

- (b) *AEMO* has provided the *metering data agent* with a written statement specifying the function, or functions, under the *market rules* for which *AEMO* requires the *confidential information*.

- (5) A *metering data agent* who receives a request from *AEMO* under clause 7.6(4) must comply with that request, notwithstanding any other provision of this *Code*.

- (6) Information received by *AEMO* under clause 7.6(5) is deemed to be confidential information under the *market rules*.

- (7) *AEMO* may only use information received under clause 7.6(5) for the purposes set out in its statement provided under clause 7.6(4)(b).
